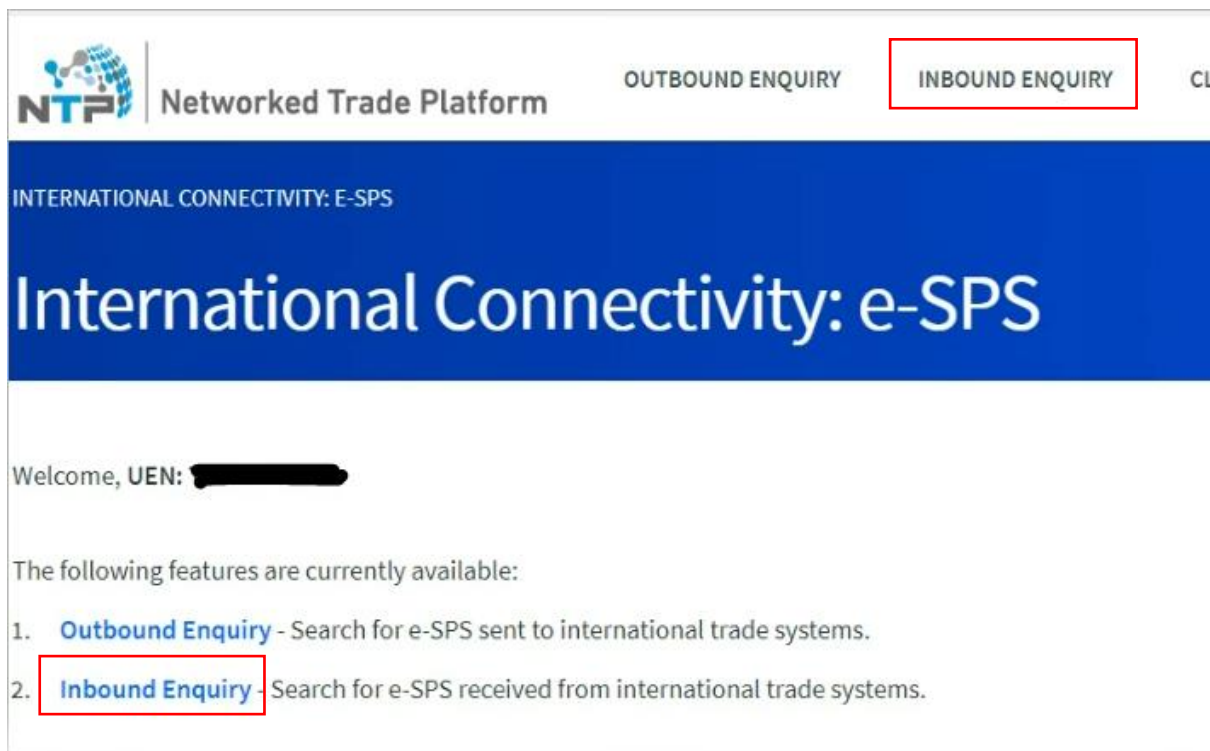



Electronic Sanitary & Phytosanitary (eSPS) Certificate Guide on NTP

- 1) To access the eSPS enquiry service, traders and their authorised Declaring Agents will have to log in to www.ntp.gov.sg > Government Services > Electronic Sanitary and Phytosanitary (e-SPS) Enquiry Service.
- 2) To perform the query traders are to select Inbound Enquiry.



- 3) Select the 'Non-Plant' category and indicate the exporting country (e.g. Australia). Traders can then either search by document reference number under 'Key Information Group 1' or by the transmission date range of the eSPS under 'Key Information Group 2'

- 5) After obtaining the certificate details, declaring agents can use the information to declare a permit in TradeNet. It is crucial that the information are declared accurately according to the eSPS details (eg. Health certificate number, HS and product code etc). Please note that for declaring the establishment code of imported meat and meat products, to key in the country prefix, followed by the processing premises ID, i.e. AU77 based on the example of 4(d), at the 'CA/SC code 1' field in TradeNet during permit application.
